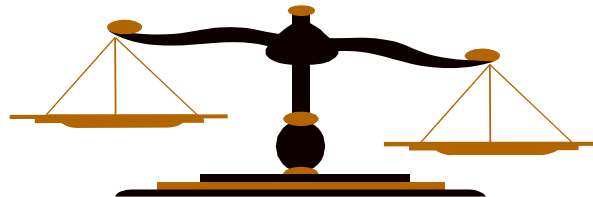

There are many lawyers practicing in the Turks & Caicos Islands; this list includes only those who wish to have their names appear. The names are arranged alphabetically and the order in which they appear has no other significance.

The Turks & Caicos Islands are a British Dependent Territory located 575 miles south of Miami and 39 miles south and east of Mayaguana in the Bahamas, and constitute a small archipelago of eight major islands and numerous uninhabited cays. The eight major islands are from east to west; Salt Cay, Grand Turk, South Caicos, East Caicos, Middle Caicos, North Caicos, Providenciales and West Caicos. The majority of the population is concentrated on the islands of Grand Turk (Capital) and Providenciales.

The rate for first-class airmail from the United States to the Turks & Caicos is 60 cents per half ounce. Mail is routed through Grand Turk to each island and through Miami to other destinations. Cable service is operated by the British Government and is available to all parts of the world. Collect cables to individuals are not accepted, but collect telephone calls may be placed. Direct dialing service to the other islands is also available. **The country code is 649.** The Turks & Caicos Islands are included in the Consular District of the U. S. Embassy in Nassau, Bahamas. The U. S. Embassy, Nassau is dialed directly from the U. S. at **1-(242)-322-1181.**

The Hague Convention on the Service Abroad of Judicial and Extra-Judicial Documents in Civil or Commercial matters is in force in the Turks & Caicos Islands. Requests for this service should be sent through the Governor's Office in Grand Turk for the Registrar of the Supreme Court, Turks & Caicos Islands.
